The Catholic Community Foundation provides "*FOREVER VALUE*" for Catholic organizations by establishing and growing endowments, providing Donor Advised Funds, and educating our Catholic community about Legacy Giving.

Our core value is providing donors the opportunity to participate in the development of funds that generate grants for our local and broad Catholic community.

#### Other Benefits of the Catholic Community Foundation:

- o All funds managed under United States Conference of Catholic Bishops guidelines
- As a repository of grant requests for the local Catholic Community, we can inform donors about effective programs that would benefit from their support
- We partner with Colonial Consulting, various individualized investment managers, and a sophisticated investment committee to optimize investment returns
- We offer donors the option to *retain a private financial advisor* with a gift of ≥\$1 million
- We accept complex gifts such as real estate, operating partnership shares, charitable trusts, etc.

# Start a Donor Advised Fund

Donor Advised Funds (DAFs) offer flexibility in your charitable giving. We provide you with information about opportunities to meet needs in our Catholic community. Schedule time to discuss how you can move money to a DAF with us for immediate tax deduction and then decide later which charities you wish to support. ### Set up a Designated Endowment

Designated Endowments provide permanent support to a parish, school, organization, or ministry you love. From the endowment, we make annual distributions to that institution or ministry - *FOREVER*. #### **Open a Field of Interest Endowment**

Field of Interest Endowments provide ongoing support and reward good works in an area that inspires you, such as youth ministry, support for the elderly, liturgy, etc. From this endowment we make grants to specific projects that fit your definitions via an application cycle. # Simplify Existing Family Foundations

To reduce administration and regulation complexity, consider transitioning to a Donor Advised Fund. There are no minimum distributions and no separate reporting requirements. If you want to keep your family foundation but sometimes find the 5% minimum distribution unwieldy, you can simply "spin" the 5% into a Donor Advised Fund with us, and then advise grants on your own schedule.
