# Strength through endowed funds and grantmaking, forever

The Catholic Foundation was established in 2004 as a 501(c)3 non-profit organization. We are a public charity, independent of the Diocese of San Jose.

In August 2012, we added COMMUNITY to the name indicating a vision to become an umbrella for Catholic philanthropy in our valley, broadening fund development to support Catholic ministries. The Board oversees the funds with professional management and fiscal accountability. All funds are managed under the guidelines of the U.S. Conference of Catholic Bishops.



It is the vision of the Catholic Community Foundation to increase Catholic philanthropy, matching donor intent with unmet needs. Our core value is working with donors to develop funds to be used in the context of our Gospel values.

We strengthen our Catholic community through grantmaking to support parish, educational,

religious, charitable, and other Catholic organizations in the county. To do this we build "forever value" through endowed funds.

An endowment is a permanent fund invested to produce income for a particular purpose. Over time, only the income is granted. The Foundation will hold an array of endowments that will be managed and invested together. Since endowments are maintained in perpetuity, when you start or add to an endowment, your donation continues to give forever.
